



Other matters not affecting our opinion which we draw to the attention of the council:

We were required to return the Annual Return to enable the Council to correct an error in Section 1. A calculation error in Box 6 caused figures in box 7 to differ from figures in the bank reconciliation. The issue has been resolved in the amended Annual Return. In future the Council needs to ensure that the Annual Return submitted for audit review is accurate, complete and agrees to the Council's underlying accounting records.
