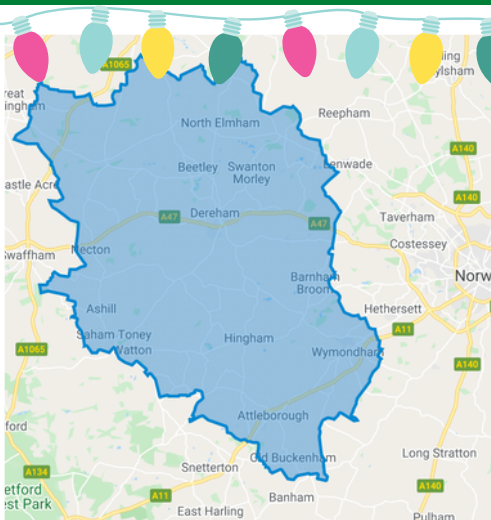

GEORGE WORKING HERE IN MID NORFOLK

As a committed local Constituency MP I have always relished the chance to make a difference here locally, as well as to represent our area in Parliament & Government. Our area faces many challenges which I continue to work on trying to solve with local community groups, civic leaders, councillors & behind-the-scenes pressure on Government & public sector agencies. Making a difference locally continues to be my number one priority as your MP. Here are some of the projects I've worked on this year:

TACKLING NORFOLK'S FLOODING PROBLEMS

Flooding has long been a concern for many in our part of Norfolk - and the heavy rainfall of December 23rd-24th 2020, and again in the early part of 2021, resulted in a record number of call-outs for Anglian Water, the Environment Agency and Norfolk County Council alike, exacerbating these long held frustrations and fears.

That's why I decided to band together with local councillors in some of the most affected communities, and bring together community groups and officials of NCC, Anglian Water and the Environment to form a Mid Norfolk Flood Partnership - an open forum in which specific flooding issues, historic wider issues and how the system for responding to and mitigating flooding events needs improving can all be discussed.

We were delighted when the Norfolk Strategic Flood Alliance first recommendations included most of the 14 points that we had ourselves suggested in our letter to Lord Dannatt. The NSFA's news that they would tackle 'tranches' of the worst affected communities was also greatly welcomed - with the first tranche set to include 16 towns and villages hit especially hard earlier this year (of which 6 are located in Mid Norfolk).

This comes as a tremendous relief - and Lord Dannatt's assurances that second, third, fourth... tranches will follow is positive news indeed.

SUPPORTING THE LOCAL HOSPITALITY SECTOR

Covid hit our hospitality hard, with many businesses facing difficult decisions and unprecedented challenges.

That's why I was keen to do all I could to support them, lobbying the Chancellor and HM Treasury for additional Covid support and responding to thousands of emails from local pubs, cafes, restaurants - always raising their views with Ministers and officials to strengthen the voice of this key local sector.

As a constituency MP and now a BEIS Minister once again, rest assured, I will continue to do all I can in the weeks and months ahead to support this sector, as well as Business more generally, as we look to move through Covid to much better times.



SUPPORTING HEALTH AND CARE SERVICES

As a former health minister and someone who worked with health based companies that support the NHS prior to becoming an MP, I know first-hand how incredible our NHS and social care services are. The last eighteen months have only heightened my deep respect for their staff, who I know we all love and cherish.

I have kept in close contact with our local hospitals and many working in GP services and in care. As we look to move on from Covid, I have visited local dental practices to find out more about the difficulties my constituents often have in getting seen; met with GPs to hear about the challenges they face on the frontline; kept in close communication with the head of the N&N; spoken with leaders in our local care sector; and followed closely the information and advice Norfolk's Public Health team share with us MPs every couple of weeks.

Rest assured, I will continue to speak up for our health and care sectors in 2022.

SUPPORTING SPECIAL EDUCATIONAL NEEDS AND DISABILITY SCHOOLS

How we take care of, and educate, some of our most vulnerable people is a measure of us as a society. **EVERYONE** has the right to a good education.

I have always been a vocal supporter of SEND education here in Mid Norfolk - helping to get the campaign for the relocation of Chapel Road School in Attleborough to a new state-of-the-art facility in Old Buckenham over the line and regularly visiting them at Christmas, as well as lobbying for increased SEND funding for our rural schools.

For the past couple of years, I have been working with Jane Hayman and her wonderful team at Fred Nicholson School as they look to find a proper, long term solution for their fast declining school buildings. I remain firmly committed to supporting them with that work in 2022.



TACKLING DOMESTIC ABUSE

Two women every week are killed by a current or former partner. 1 in every 3 women will experience domestic abuse in their life. Norfolk saw a 40% increase in domestic violence in the pandemic.

These are truly shocking statistics than really do need addressing urgently.

Recently, I convened a roundtable with the key local leaders, the local Daisy Programme and other domestic abuse charities and support groups to look at how we can make a difference locally, as well as lobby the Government. I look forward to continuing this work next year.

REGULAR SCHOOL VISITS TO TALK TO STAFF, PARENTS AND CHILDREN

Our children are the future of our great country and county, and that's why I regularly visit Mid Norfolk schools to speak to staff, parents and most importantly pupils!

This year I've had the pleasure of visiting the likes of [Attleborough Primary](#), [Necton Primary](#) and [Morley Primary](#) (amongst others) to speak to some of our youngsters about the issues that most concern them - from climate change and the environment to job opportunities, exams and mental health.

I have also supported our local councillors as they look to deal with lack of parking and speeding outside of schools (such as outside of [Robert Kett](#) in Wymondham) and, in [Carbrooke](#), I am working with councillors once again to see what we can do about the absence of a suitable bus service and the current, unsafe walking route that has worried parents and teachers for too long.



DRIVING FORWARD A NET ZERO PATHFINDER

Norfolk is set to be on the forefront of the Green Energy Revolution, but how do we help SMEs and households make Net Zero a reality?

That is the question that I have been posing to the Norfolk Enterprise Festival's "Magnificent 7" group - a team of leading entrepreneurs in the seven fastest growing sectors of Norfolk (and Suffolk)'s economy.

Massive infrastructure like an integrated Offshore Wind network, Freeport East and the Sizewell C improvements are all crucial, but we must all deliver much smaller, tangible successes at the grassroots too.

I look forward to working with the Mag 7, the LEP and partners to see what a Net Zero Pathfinder in the East might look like, and how we can make it a reality.

HARNESSING THE HYDROGEN REVOLUTION IN THE EAST

Did you know that transport emissions are the largest source of greenhouse gas emissions in the East of England? 42% of all greenhouse gases here come from transport!

The decarbonisation of our transport network is so important as we embark on the Road to Net Zero, and I am delighted to be working with [Transport East](#) and others as we rise to that challenge.

Hydrogen has a vital role to play - in time fuelling our more localised train routes, haulage, agricultural vehicles, ships and more - and I welcomed the news that a world leading Hydroliser will be built as part of the [Freeport East](#) proposals I supported.

UPGRADING NOR-CAM RAIL

In order to develop our local economy and promote local businesses and opportunities for us all, we also need upgraded rail links that can be accessed by [everyone](#).

I have long called for the Norwich-Cambridge line to be transformed into an 'Innovation Express', helping to launch the East Anglian Rail Prospectus at the start of the last decade and then actively campaigning with colleagues and stakeholders for the upgrading of Ely North Rail Junction and Trowse Bridge so that we can get half-hourly trains. I was proud to announce as a DfT Minister that the Government's East-West Rail project would be extended East from Cambridge to Norwich and Ipswich.

Having lobbied and helped win a commitment for an entire new, modern, more accessible train fleet in the last franchise, I also reconvened key stakeholders to get access to platform 2 of Wymondham Station improved too. Funds have been secured and I am now supporting South Norfolk Council and Greater Anglia as they look to finalise plans in the spring.

Longer term, I want to see our Mid Norfolk stations transformed into high quality community/business hubs with 5G internet - as well as the Wymondham-Dereham line reopened for a basic commuter service.

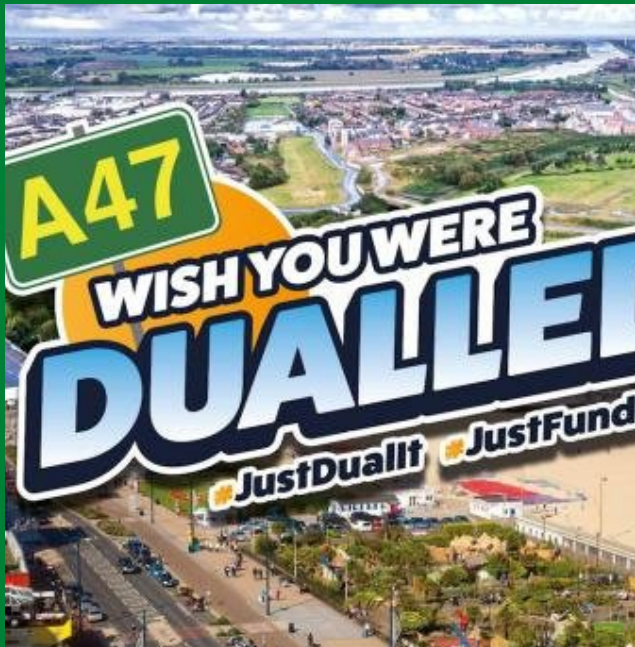
SUPPORTING A PROPER OFFSHORE WIND SOLUTION

Norfolk, and the East, are on the brink of becoming the 'Saudi Arabia' of Offshore Wind production. The Southern North Sea will be the global hub - putting our region at the forefront of the UK's 'Green Revolution' and bringing thousands of new jobs and opportunities.

I continue to actively work with parliamentary colleagues and local communities to drive forward the campaign for an Offshore Transmission Network - to avoid the needless environmental damage to our precious rural and coastal landscapes, along with the major disruption that businesses, tourists and communities encounter when each wind farm cables inland to Wembley Stadium-sized Substations.

IMPROVING OUR ROADS

For too long, successive governments on all sides of the House have failed to properly invest in road infrastructure in the East.

I was delighted to work with fellow eastern MPs to get a government commitment to full dualling of the A11 at the start of the last decade, and why I was over the moon to bring the then PM to Hockering in 2014 to secure a £300 million commitment to dual the North Tuddenham-Easton stretch of the A47.

I continue to actively lobby National Highways to ensure there is no further slippage in construction of these A47 improvements - and expect full works to begin in 2022. We must go further however, and that's why I support the A47 Alliance's campaign to secure full A47 dualling - from Lowestoft in the East, all the way to the A1 in the West.

My work to support a local A47 Taskforce in the Honingham to Wymondham corridor is ongoing too - with the group drawing up promising plans with NCC to ensure that there is a proper strategy to deal with increased rat-running as a result of the nearby A47 improvements and potential Norwich Western Link.

REFORMING OUR PLANNING SYSTEM

Building enough houses to make sure everyone in our area has the chance for a home of their own, while also making sure we protect our rural landscape and heritage, is often a difficult balance.

Since becoming MP for Mid Norfolk back in 2010, I have worked with local community groups and councillors to promote a more local and organic model of development, and endeavoured to make sure everyone's voice is heard. Whether that be to protect the Lizard or the Tiffey Valley in Wymondham, or to oppose an inappropriate and unsustainable development in Watton or Dereham, where there is a danger of large-scale over-development, I will always speak out to make sure we protect our landscape and heritage.

What we need is a long-term plan led by local communities. That's why I made submissions to the National Planning consultations last year, and why I welcomed the Government's announcement that they would go back and reconsider their Planning reform proposals in light of considerable feedback.

We need to stop huge edge-of-town commuter housing estates & insist on proper community planning with infrastructure, green space & infrastructure & facilities.

BACKING LOCAL BUSINESS

Having worked for fifteen years as an entrepreneur before coming to Parliament and having served previously as a Business Minister, I passionately believe in the potential of Norfolk's rural economy to play a significant role in helping to rebalance the national economy and create prosperity and opportunities across our area - especially as we look to Build Back Better post-Covid.

Too often rural businesses suffer from isolation and struggle to access the finance and support they need. Many of the market towns and high streets in Mid Norfolk face real challenges as the older local manufacturing businesses and jobs leave, while villages suffer from closing Post Offices and pubs.

In response, I set up the Norfolk Enterprise Festival to give the tens of thousands of SMEs and local entrepreneurs a fun, family-friendly event to come together, promote themselves and network - and I work with local councillors, council officials, parish councils, the New Anglia LEP and businesses themselves to emphasise Norfolk's (often hidden!) entrepreneurial spirit. The modernisation of our Job Centres & introduction of Universal Credit has transformed the service to jobseekers. Our local DWP teams - led by the excellent Julia Nix - are doing great work helping place jobseekers in work.

With many sectors like food processing, haulage & catering experiencing labour shortages after Brexit & Covid we urgently need to get more jobseekers into practical frontline vocational job training.

REGULATION FOR INNOVATION

Nothing better illustrates the advantages of being outside the EU than the UK's vaccine success. Our leadership in genomics, vaccine research and development, accelerated access trials and our ability to procure at speed has allowed the UK to lead the world in the battle against the pandemic. This year has truly been a London 2012 moment for UK Life Science.

That's why I was delighted to accept the Prime Minister's invitation in the summer to help lead the new Taskforce for Innovation, Growth and Regulatory Reform (TIGRR) with Iain Duncan Smith and Theresa Villiers. We came from opposite sides of the Brexit debate but with a shared determination to make this a moment of profound renewal. The urgency of the post-Covid recovery makes this more essential than ever. Our TIGRR report published in the summer shows how the UK can deliver on the promises of Brexit without abandoning our high standards. Liberated from EU red tape, this is a once-in-a-generation opportunity. We must seize it.

Reform for Resilience

Healthy Growth

BUILDING A NEW HEALTH ECONOMY

COVID-19 has revealed that the world was not prepared for a pandemic that we had every reason to anticipate. We neglected to adequately invest in developing and maintaining global health system resilience. Consequently, the COVID-19 pandemic should serve as a wake-up call to global leaders every bit as significant - and urgent - as the Global Financial Crisis (GFC) of more than a decade ago, and the worsening climate emergency of today. They are linked. The pandemic, the GFC, and the climate emergency are all crises of resilience, testing our ability to adapt and thrive.

This year I launched the Reform for Resilience Global Health Commission, along side co-chair Malcolm Turnbull, Jose Manuel Barroso and Michelle Williams. This independent Commission brings together experts from across the fields of health and life sciences, business, finance, and global political leadership at the highest level, to help inform the 2021 policy 'reset' that the current pandemic has rightly triggered.

This Commission has been created to help shape the new models, metrics and practical policy reforms to help leaders - in the public and private sectors - deliver the changes needed for healthier growth. Through our ongoing work with the OECD, G20, World Economic Forum, Cambridge Public Health, our global network of hubs and academic partners, and the other initiatives in this post-pandemic policy 'reset,' we have led the conversation about building a resilient post-pandemic world that ensures we don't let history repeat itself.

Reducing use of animals in research

The issue of animals in research is one I take very seriously indeed. It is a moral and legal issue about the values that we hold as a country.

I was proud to speak in a Westminster Hall debate recently on the issue as Minister responsible. I am personally passionate about this agenda for a whole raft of reasons. I feel very strongly that we have a duty of care as human beings to the animals around us. I also had a career in medical research before coming to Parliament in 2010 and have seen for myself the importance both of using every piece of technology to try to remove dependence on animals in the development of medicines and of carrying public trust in the research process with us.

Indeed, having once tried to found a company developing toxicology artificial intelligence-predictive software that would predict the toxicology of compounds so that we do not have to rely on animal models, I have personal experience of this fight. Treating animals humanely is fundamental to who we are as a society.

Dear Minister,

We are writing to you from Animal Free Research UK, Cruelty Free International and OneKind in order to thank you for your detailed and encouraging response in the Westminster Hall debate on animal testing on 27 October. As you may know, our organisations set up a petition (2021-26) (2021) Plan to phase out animal experiments, which is one of those that was discussed during the debate.

Finally, we thought it may be useful to provide some background information about our organisations:

- Animal Free Research UK is Britain's leading medical research charity working for a world where human research can proceed faster without animal suffering. The charity funds pioneering animal free research that saves human and animals and is forging a future where animals are replaced with modern, human relevant techniques.
- Cruelty Free International is the leading organisation working to create a world where nobody wants or needs to use animals. The organisation's dedicated team are experts in their fields, combining award winning campaigning, public lobbying, scientific and legal expertise and corporate engagement.
- OneKind is a leading campaign animal welfare charity. OneKind offers positive change for animals through high profile campaigns, animal lobbying, investigations, public education, and promoting compassionate living.

We are grateful to you for providing a considered response to the petition in the debate. We were delighted both by your compassion for animals, highlighted by having said, and your extensive background in the life sciences industry, and we would be delighted to work with you to help accelerate the pace of change, for the benefit of animals, people and the economy.

We were pleased to hear that you also said that the development of New Approach Methodologies (NAMs) represents a key opportunity for the UK to be a global leader and set a gold standard. In fact, a report (2021) by the Centre for Environment and Business Research (CEBR), which was commissioned by Animal Free Research UK, highlighted the major economic potential of NAMs. This estimate that in 2035, the UK health industry contributed £2.5 billion to turnover and £200 million to Gross Value Added (GVA) to the British economy. Securing better royalty rights for artists

Securing £350m for MND Research

People living with neurodegenerative diseases could live longer, healthier lives due to innovative new research.

I was delighted recently when the Government committed £375 million over the next 5 years for the vital research necessary for MND sufferers.

At least £50 million will be made available specifically for research to help find a cure for MND - a condition that affects the brain and nerves and affects 5,000 people in the UK and many people here in the east.

New, innovative projects will help researchers to better understand the disease and its related conditions, develop and test treatments and improve care for those living with MND.

The full £375 million investment will fund projects into a range of diseases such as Pick's Disease, Frontotemporal dementia, Wernicke-Korsakoff, Parkinson's disease dementia, Lewy Body dementia, Alzheimer's disease and mild cognitive impairment, improving our understanding while searching for new treatments.

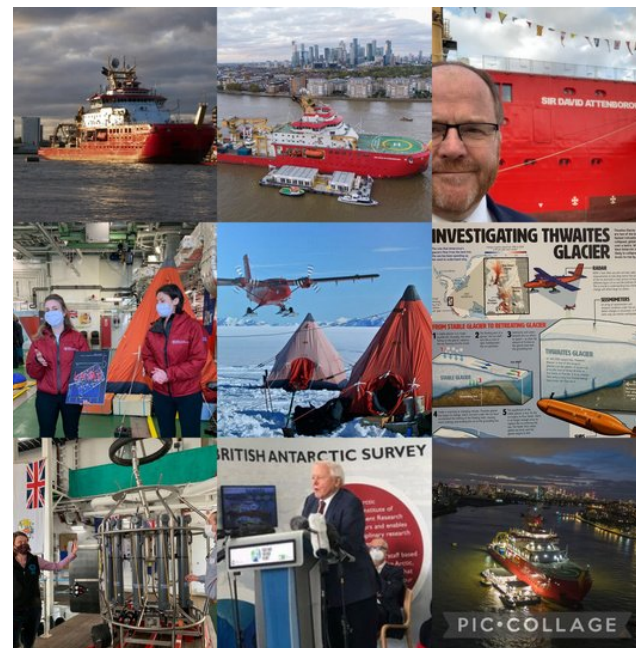
Supporting British Antarctic Survey on board RSS Sir David Attenborough

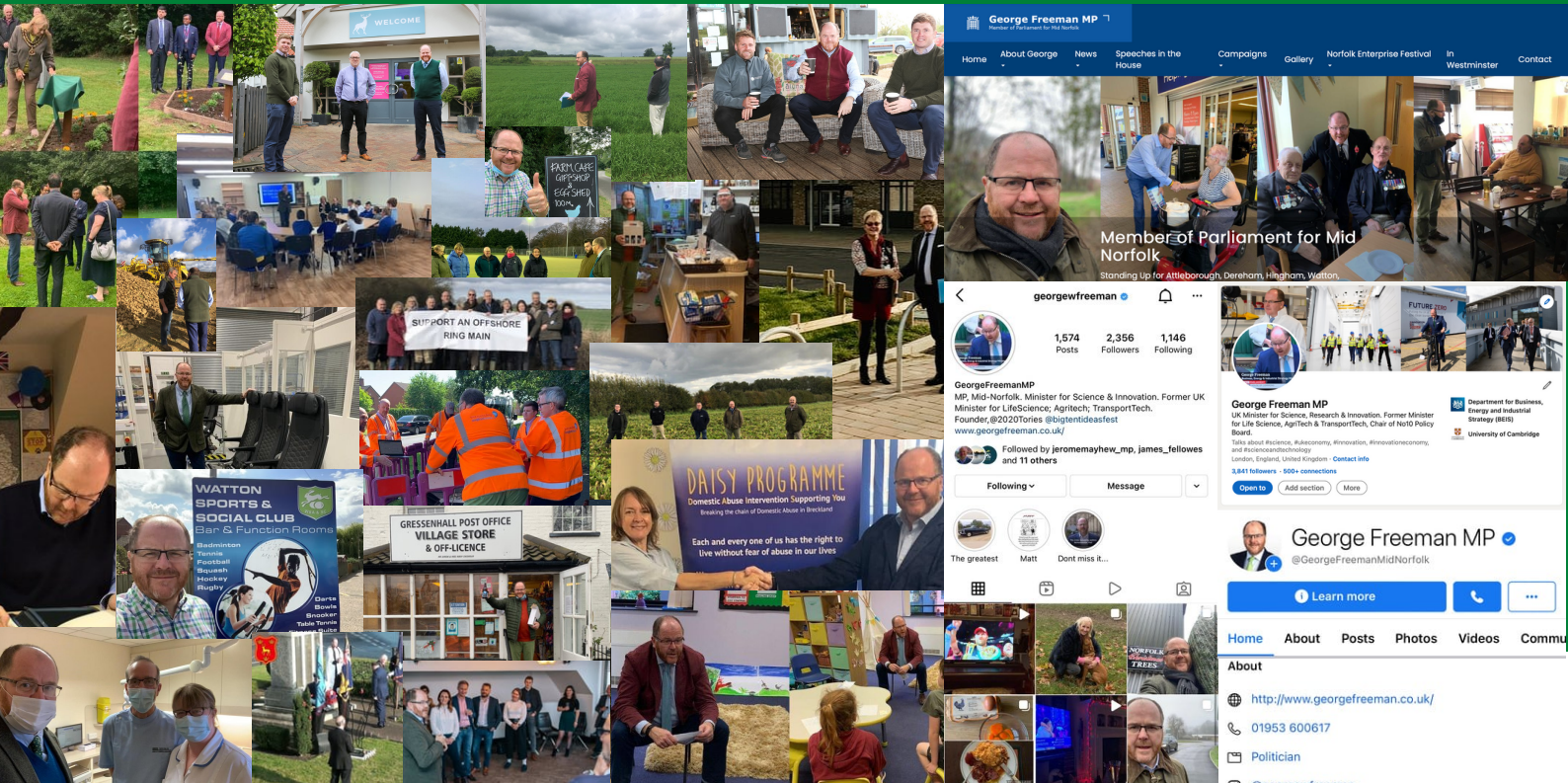
ACCESSIBLE AND ACCOUNTABLE TO YOU

I remain committed to trying to make my work accessible with my programme Digital Democracy, so people who are busy and want to stay in touch easily online can do so at the press of a button.

I believe its very important for MP's to be seen and accessible locally. I do this through a number of ways:

My social media channels, my website, through email, and through calls to my office here in Norfolk and also in Westminster.

Toward the end of the week when I return from Westminster I also visit as many towns and villages as I can, and (covid rules permitting) a range of outreach programmes such as my supermarket surgeries and politics in the pub events.



With 5 towns & 114 villages across a constituency with a 90mile boundary, it's impossible to visit every village, pub or community centre regularly.

Each Friday & Saturday I pack in as many visits as I can, and move my surgery around to make it easy for the less mobile.

It's why I also work hard on digital outreach - through my Website, Facebook, Instagram, Linked-In & regular targeted Bulletins to key interest groups.

Each week we receive 1000+ pieces of correspondence from constituents, which Ruth & Elliot and I sort, prioritise & respond to. (With so much Covid-related correspondence we no longer reply to hostile party-political correspondence: we prioritise constituents who most need their MPs help.)

This year we have dealt with:
helping c6000 individual constituents with new Casework
dealing with another c3000 existing/open casework cases
progress on 25 important local projects/campaigns

As a rural area we are home to much silent suffering of people isolated & lonely. But we are also a famously strong local community.

Let's all do all we can to keep an eye out to help our vulnerable neighbours this Christmas.

Thank you to all those of you who do so much as volunteers, carers & hidden heroes behind the scenes.
