## We are on track for the new Early Childhood and Family Service (ECFS) to 'go live' from 1st October 2019

#### With the contract successfully awarded to Action for Children, the new service will:

- ✓ Provide targeted support for families with children aged 0-5
- ✓ Offer help so that all families can connect with local support and universal early childhood activities
- ✓ Operate from 15 early childhood and family bases & use a large range of local delivery venues
- ✓ Contribute to joint working and maintaining partnerships to secure a district early childhood offer



## How families will be supported in their local area

From 1<sup>st</sup> October there will be a new service for 0-5 year olds and their families in Norfolk.

Norfolk's Early Childhood and Family Service is for all parents and carers with children aged 0-5 years. How and where you get support will depend on what you need.









#### **Everyone will be able to:**

- Get help online.
- Chat on the phone or online from 1st October.
- Visit the local library to get information, weigh their baby or join in with Bounce and Rhyme sessions.

#### If you want help meeting other parents, or need someone to talk to:

- Come to a drop-in event at a community venue this could be a library, community centre or café.
- Our team will attend community groups regularly, so you can come and chat.
- We can also help you to set up your own local groups and activities.
- We can give you a list of all the events and activities happening locally like baby massage, toddler groups and play sessions.





#### If you need extra help:

- We will offer support to you and your family through drop-ins and groups.
- We will also support you in your own home, or where you feel comfortable.
- We can put you in touch with other people who can help.










Working with families who need extra help.

One to one support in people's homes or in community venues





This will include specific activities, such as parenting courses, baby massage...

Supporting other lead professionals, such as health visitors or social workers.

Group support – this might be open to everyone in areas of high need or might be for families who are referred in other areas.









# Where will the service be based

- There will be 15 bases two in Breckland, South Norfolk, Broadland, West Norfolk, Great Yarmouth and North Norfolk and three in Norwich.
- However, the service will cover the whole county and will be delivered largely on an outreach basis.
- Services will be taken to people's homes, community groups, libraries, health centres and other suitable community venues
- The 15 bases will be used to coordinate services, as well as to provide joint spaces for services and organisations to work together.











# What is the offer for everyone else?

- Providing information, advice and guidance when families initially ask for help. This might be online, face to face, or through staff attending local community led groups.
- Offering regular drop in sessions for families, wherever possible with other services.
- Helping families with practical support to build their own 'networks of support'.
- Enabling parents to support other parents as 'parent champions'.











## Working together

#### The new service will:

- Work with other agencies and services to develop a district offer;
- ✓ Help families access the support they need in their area this will vary from family to family but could be speech and language therapy, support for their metal health, access to work and training or advice on caring for their child.
- ✓ For families needing extra help, the service will work with partners to build a team around the family.
- ✓ Work with partners to monitor the impact of the service.
- Norfolk is one of 5 areas nationally selected to be part of a new Early Years Transformation Academy, working with the Early Intervention Foundation.

"Only by better working together as a whole system, will we achieve the impact and outcomes needed for families and children."

#### Design workshops


Interactive and applied workshops delivered in the local area which give the four EYTA Teams space to actively test and develop their plans, encouraging peer collaboration and support across the Teams.

#### Childrens Centres: Sites still to sign off

Childrens Centre	RAG	Reason for RAG (if not Green)
Attleborough	Amber	Community hub solution creates difficulty with proving to DfE majority of usage is for 0-5's. Exploring option of writing the values of the £0.2m assets off (We believe DfE will accept depreciation to zero as assets now 10 years old).
Bowthorpe	Amber	Identified solution for the centre to become a childrens contact centre. Dependant on NCH&C surrendering their lease for the building and NCC negotiating an acceptable lease from Norwich City Council.
Caister	Amber	School business case to use space for an SRB does not protect clawback liability (£0.5m). Childcare sufficiency requirement for space to be used to increase nursery provision. Working with education teams to identify workable solution.
Dereham	Red	Substantial financial outlay required for anyone taking on the building due to its size, age and condition. Exploring possible interest with the Engage and Unity Trust for a SEMH school, if not the building will most likely be sold.
Hunstanton	Amber	Added complexity of childcare provider (Spring) giving notice to exit site as well. Following tender a successful childcare provider has been found. Discussions to be had with the new childcare provider and Hunstanton Town Council regarding who will take the head lease and their partnership working.
Methwold	Red	Thatched, grade 2 listed building status, cottage in school grounds, which require extensive building maintenance. Interested childcare provider has pulled out due to the condition and future liability associated with the building. We are now following up with Weeting Infant school to see if they will take on the building as it is in their grounds. Usage will need to be for 0-5 though as £0.1M clawback liability.
St Clements	Amber	Within academy school grounds and academy WNAT have requested to take the space back. We have not yet had details of their proposal, so are yet to ensure that these protect our £0.4m clawback liability. The space is leased to NCC, so if WNAT do not use the space for 0-5's we will retain the land and identify our own childcare provider.
Thetford Canterbury	Amber	Within academy school grounds and academy DNEAT have requested to take the space back. We have not yet had details of their proposal, so are yet to ensure that these protect our £2m clawback liability. The space is red lined, so if DNEAT do not use the space for 0-5's we will retain the land and identify our own childcare provider.
Thorpe Hamlet & Heartsease	Red	Multiple interest from the school, nursery provider and People From Abroad Team (PFAT). Formal business case not yet received from the school, although they have indicated to our education teams they wish to take over the space. Meetings to be set up with interested parties to see if they can work together in the space.
