DECLARATION OF INTEREST

No interest was declared in the agenda.

A dispensation was granted to all Parish Councillors in order to discuss the Precept and other financial matters.

PUBLIC SESSION

The dedication of the footpath has now been signed, so hopefully the application to revise the variation of condition by Clayland will be rejected. We will also request the 30mph flashing speed sign which was promised at the time.

A resident asked if the PC had investigated the non-attendance of two Parish Councillors. The chairman said this matter will be looked into.

On 8th September Breckland Older People's Forum is hosting a Question Time on the future care of older people, this is open to everyone.

CORRESPONDENCE

Audit: The certified Annual return was received for the financial year ending 31st March 2017. There were no issues arising from the audit. The completed return will be uploaded to the website.

Play Area Inspection Report: Zurich Insurance inspection report was received and the following comments were made: - It is recommended that both gates to the fenced play area open outwards. The gates were fitted to open inwards and the PC feel that at present they should be left.

Copy of a letter sent to the Traffic Police was received from Mr David Eaton, regarding the total lack of enforcement of the 30mph speed limit through the village. The Clerk will write to the traffic police and see what can be done.

Gym Equipment – M Brigstock advised the PC that many villages are now installing gym equipment. This may suit Bradenham and we could install it to one side of the play area. The Chairman ask for information regarding this to be sent to all the PC and we can look into it further.
