Tim Birt – District Councillor

106 agreement has been a problem for many years. Thousands of villages have lost out. New officer is now in place and we are hoping this will now be sort out. We cannot guarantee any old funds will be given distributed.

Local plan will be a binary decision, it will be either accepted as a whole document or not at all.

Planning generally approves more green field sites. Brown field sites are more expensive than green field

Helen Crane – District Councillor

Grants are available for the VE day celebrations. We had the Poppy Day flag raised and 2 minute silent around the county. A white flag ribbon was also raised for the fight against domestic violence.

Green Britain centre in Swaffham may become a community area.

The department that deals with the Fly Tipping problem has issued several fines. Please encourage residents to report fly tipping, it is very easy to do this online

Public Session

PC Paula Gilluley sent her apologies for not be able to attend.

The footpath has still not been started. The Chairman read out an email received from Sue and Andy Smith – As you know we spoke to Kay Gordon from Breckland Highways when she did a site visit with Chris Tilley (mid-September) to discuss the road widening. Kay asked if we would still donate the land required as per original agreement which had expired. We indicated at the time this would be acceptable to us and subsequently confirmed this via email the next day. Kay and her team were to discuss this further with Chris Tilley and come back to us once they had reached an agreement. Kay had said she would 'keep us in the loop however, as yet we have had no further updates or contact from any party involved. One can only assume no progress has been made.

Helen Crane stated that she expected the path to have been started by now because Highways had now accepted the 'Trod' footpath and this will be looked into.

There is still a problem with the ditch (Hale Road/Church St), Chris Allhusen will email John Cotton.

The PC thanked Tim Shakesby for rodding near the Lord Nelson and clearing the water off the Highway.

A resident pointed out that the cricket club square being roped of is quite dangerous when you walk cross the green in the evening, even with a torch. The clerk will ask the club if they could put something reflective up.

MATTERS ARISING

Highways – Email read out from a resident regarding speeding traffic and over hanging trees and the email that was sent to highways by the same resident. PC agreed that the roads are narrow, but there is not much that can be done.

Trevor Nelson wrote to Norfolk Highways requesting for a Highways traffic assessment due to the volume of traffic through Bradenham and for the safety of residents. Highways do not feel this is necessary and traffic calming measures, which are very expensive, cannot be justified in small villages.

Speed Watch – Monitored 133 vehicles travelling through Bradenham in one hour today. The flashing signs do help but in between them, vehicles still speed. Kim Findlay mentioned that vehicles do speed going up Littleproud Hill so they can get to the top without meeting other vehicles going down. Steve Welton asked the PC to support Trevor Nelson in going further with Highways, it was agreed they would do this. Chris Allhusen will email John Cotton of Highways.

Village Green Bylaws - This was placed in the November Mardle and so far, only one resident comments. As agreed we will give residents 3 months to comment and after that it needs to be advertised and then it up to the Secretary of State to make a decision.

Clayland Footpath – See Public Session

Playground Inspection Report – Chris Allhusen ordered and replaced the following seat – 2xCradle seats and 3xFlat seats including the chains.

Dog Mess on Green – This is difficult to deal with, we need to be vigilant. Fines can be imposed.

Cleaning The Ford - Thanks must go to the small group of volunteers of Michael Murray, Jake Tinsley, Steve and Lesley Welton. Our thanks also goes to Chris Allhusen for providing a trailer and disposing of the rubbish.

CORRESPONDENCE

Precept – This was discussed and the PC agreed to keep it at the same level has last year £8000.

Bank Account – Paul Jarvis is still on the account due to the Nationwide losing the form. Paul has resigned a form and that will now be monitored by a member of the branch. We have also verbally been advised that the business investor account will be closing in the new year and an alternative will be offered. The PC agreed that the Clerk writes to NALC to ask them what banks do other PC's use.

Charity Letters – Two received – Norfolk Citizens Advice and Norfolk Accident Rescue Service. The PC had decided not to give to charities and instead spend the money in the village.
